The challenge for businesses is demonstrating their sustainability progress to their consumers. Whether it's reducing energy and water consumption or managing waste more effectively, accurately measuring such initiatives can be costly and time-consuming.

Comply with Environmental Regulations

Compliance requirements vary from country to country. Collecting and managing the right data to meet local regulations can become difficult. Companies struggle with multiple internal tools and complex spreadsheets, which do not always share data. There can be hundreds of indicators to monitor, some of which may be measured in different formats depending on location. These must be aggregated, validated and interpreted using a consistent methodology.
