Collect Accurate Data

Companies need to accurately collect, analyze and report emissions data, but calculating emissions of complex sites and operations is not simple. Companies need to ensure that they use the correct methodology and that emissions data is auditable. Once the right data has been gathered, accurate calculation still requires the use of the right emission factor for the activity, emitted gas, geographic location and date. Generating external reports is also time-consuming and prone to errors.

Turn Data Into Insights

Most companies also struggle to turn this data into actionable insights that reduce their emissions and energy consumption. Collecting the data is one hurdle, but inflexible reporting tools prevent data consolidation across multiple sites. This results in an inability to perform effective scenario analysis, and to anticipate future GHG emissions with the aim of preventing them.
